## Minutes of the 2<sup>nd</sup> meeting of the State Level Steering Committee (SLSC) on 6<sup>th</sup> Minor Irrigation Census and 1<sup>st</sup> Census of Water Bodies held on 07.03.2020 at 1.30 PM.

The 2<sup>nd</sup> meeting of the State Level Steering Committee (SLSC) on 6<sup>th</sup> Minor Irrigation Census and 1<sup>st</sup> Census of Water Bodies was held on 07.03.2020 at 1.30 PM in the Conference Hall of Planning and Convergence Department under the Chairmanship of the Development Commissioner-cum-Additional Chief Secretary, Odisha. The list of officers present in the meeting is at Annexure-I.

Joint Director, DE&S presented the summary findings of 4<sup>th</sup> and 5<sup>th</sup> Minor Irrigation Census and progress of 6<sup>th</sup> MI Census and 1<sup>st</sup> Census of Water Bodies in the State as on 31.01.2020 with 2017-18 as reference year.

After due deliberation, the following decisions were taken:

## 1. Summary findings of 4<sup>th</sup> and 5<sup>th</sup> Minor Irrigation Census

- (a) Physical Progress: SLSC took note of the result of 4<sup>th</sup> and 5<sup>th</sup> M.I. Census along with sectorwise growth and comparison with all India result.
- **(b)** Financial Progress of 5<sup>th</sup> M.I. Census: Rs. 486.63 lakh received from Government of India under 5<sup>th</sup> M.I. Census and Rs. 391.42 lakh was utilized (Rs. 214.24 lakh during 2017•18 and Rs. 177.18 lakh during 2018-19) leaving an unspent balance of Rs. 95.21 lakh.

Out of the unspent balance of Rs. 95.21 lakh, Rs. 37.42 lakh has been revalidated by Government of India for payment of pending dues of honorarium of 5<sup>th</sup> M.I. Census during 2019-20 and Rs. 57.79 lakh had been adjusted towards 6<sup>th</sup> M.I. Census.

(a) Honorarium for coordination, supervision and monitoring of 5<sup>th</sup> M.I Census: Basing on Government of India approved rate of honorarium for coordination, supervision and monitoring of 5<sup>th</sup> M.I.
