1. Objective

2. Scope of Work

The agency selected by DES will be required to develop short audio – video visual contents (each of 2-3 minutes of duration) in 2 languages English and Odia on Statistical Field activity.

- a) The Agency will be responsible for carrying out all the conceptual, creativity, designed, development, technical & production work which are required for production of the audio video visuals content.
- b) Story boarding and script writing based on the content required for the development of the videos as per client's briefing. Script writing and content building will be done by the agency in consultation and approval of the DES.
- c) Videos will be dropped with the subtitles in 2 languages (Odia & English)
- d) Shooting of all the contents for the video shall be done in full HD format only.
- e) Costume made renderings and animation with actual high resolution video shoots including Aerial photography via drone camera to demonstrate the entire area of operation.
- f) All the raw data and recordings with final outfit shall be the ownership of DES and the same has to be submitted along with the final submission.

4. Eligibility Criteria

- i) The agency must have the average annual turnover of minimum INR 20 Lakhs from the production of Audio-Visuals creatives and related jobs during last 3 financial years.
- ii) Agency shall have adequate experience of producing creativity, media planning, and video (film/documentary/TV) content.
- iii) The biding agency shall have adequate infrastructure, dedicated and experienced technical and skilled person to execute the work.

- B. Financial Evaluation shall be carried out from the shortlisted agencies after the technical evaluation. The selection will be based on least cost selection method.

- 10. The quotation will be opened at 3.00 PM on 18/01/2024 in presence of the quotation/ authorised representative in the conference hall of DES.
- 11. The delivery of items should be within 5 days of acceptance of work order.
- 12. The rate in the Quotation should be free from corrections and errors. In case there is any difference in rates written in figures and words the rate quoted in words will prevail.
- 13. The Xerox copy of valid GST Clearance/ ITCC Certificate /DIC registration (if any) duly self-attested & Application fees for Quotation of Rs.200/- in shape of DD should accompany the quotation, failing which the quotation will be liable for rejection.

23. Penalty

i. Time of completion, being essence of the contract, the successful Agency/Bidder is bound to complete the allotted work within stipulated time frame as per the job order failing which penalty to the extent of 2% of the total cost of the work allotted for delay of each fortnight shall be imposed upon the Agency.
